

Terms and Conditions.

How to Enter

To enter the “Movies On Us” promotion customers simply:

1. Spend \$50 Monday – Thursday at any combination of the participating restaurants, cafés or takeaway food and beverage outlets at The District Docklands, in one day and receive a Hoyts Movie Ticket worth \$26.50. (Receipts can be accumulated to reach the maximum spend of \$50)
2. Scan the QR codes displayed on signage in the precinct and complete and submit the online entry form with all requested details including name, email, phone number, suburb, state and postcode.
3. Customers will receive a message advising to review their email address to receive one The District Docklands Hoyts movie ticket.
4. Customers click on the link on their confirmation email to download their Hoyts movie ticket.

Duration of Promotion

The promotion opens at 9am, Monday 5th February 2024 and closes at 11.59pm, Wednesday 20th March 2024. Tickets will be able to be redeemed for five days from the closing of the promotion.

Conditions of Entry

1. Information on ‘how to enter’ forms part of these ‘Conditions of Entry’.
2. Customers entries are limited to one redemption per customer, per day. The minimum spend of \$50 or more must be made and a receipt as proof of purchase must be uploaded to qualify.
3. Entry is only open to permanent residents of Victoria only.
4. Employees and the immediate families of the Promoter, participating outlets and the agencies associated with this promotion are ineligible to enter. Immediate families mean parents, siblings, spouse, children and grandparents.
5. Management and staff of tenants at The District Docklands are not permitted to enter.
